# Eligibility conditions for Empanelment

- A) The Book supplier shall be a member of registered National/State Book Suppliers Association (e.g. AIPB, FPBAI, DSBPA, etc)
- B) The Book supplier shall have supplied books to the library of University/ affiliated teaching institutes/Organization for the last three Financial Year
- C) Book supplier shall have a minimum turnover of Rs 10 lakh per annum in respect to sales of books in the last three financial years.
- D) Book supplier shall have submitted the ITR of the last three financial years.
- E) Book supplier shall have PAN Card, TIN, and GST number.
- F) Book supplier shall not have been black listed/debarred by any public or private institution/organization

## Terms and Conditions of book supply

- 1. (a) CBPACS does not bind to empanel any of the Book Suppliers.
  - (b) CBPACS does not bind to place the supply order/orders to any of the books suppliers.
- 2. Incomplete or wrong information will disqualify the Supplier's request at any time(2025-2028)
- 3. Empanelment is valid initially for a period of three financial years (2024-2027), which may be extended for period of maximum two (02) financial years on the same terms and conditions.
- 4. The CBPACS reserves the right to recommend or reject any or all book suppliers for consideration of the Director-Principal, CBPACS. The decision of Director-Principal will be final in all cases in respect of acceptance/ rejection/arbitration.
