





With reference to the above reference letters, it is hereby conveyed that CBPACS has given A/A of preliminary estimate of Rs. 1,51,39,700/- and E/S of Rs. 15,13,970/- on 10.01.2023 for changing of CI pipe with PVC pipe and replacing of GI pipe with CPVC pipe in shaft and toilet blocks of hospital & institute blocks, and A/A of Rs. 3,09,63,163/- & E/S of Rs. 30,96,316/- on 09.03.2023 for renovation of girls hostel, boys hostel and doctor's hostel in CBPACS (copy attached). The said 02 works have not been started by PWD till date.

There is a major seepage problem in hospital and institute building due to rusting of CI & GI pipe lines in shafts and washrooms. Due to this many shaft are broken and leakage problem occurs. Further, it is also submitted that Sansthan have 03 Hostels i.e. Girl's hostels, Boy's hostel, Doctor's hostel. All the buildings require maintenance/repair work eg. Plaster work, door work, anti-termite work & pipe leakage problem. Girls's hostel repair/maintenance work is urgent required because the building of girl's hostel is closed since long time. Many letters was sent to PWD regarding this, but no reply received. Sansthan has been given A/A & E/S for the above mentioned work.

So, in view of the urgency of the work you are requested to give the directions to your officials to execute the work at earliest.

The matter was enquired with the complainant, witness and accused. The alleged accused submitted unconditional apology for his behavior and assured not to be involved in such activity in future. The same was accepted by committee and complainant. Meditation and counseling was also provided to complainant Mr. Amit Kumar to overcome this trauma.
2.	A complaint was received through email dated 12.06.2023 from Mr. Kaushal Pathak, BAMS student of batch 2018 - 19. The complainant has alleged that he was intentionally failed in final year examination in Panchakarma subject.	The committee enquired the matter on 14.06.23. Upon enquiry it was found that the student was passed in the practical examination of said subject and had failed in the theory examination the evaluation of which is conducted at GGSIPU following their rules and regulations to maintain secrecy. As such there was no material evidence of prejudice and the student has already submitted the form for rechecking of evaluated answer sheet to GGSIPU which was dully forwarded from the office of Addl.
